\*\* The Minnesota Department of Health interprets the term “rental apartment buildings” to mean buildings with three or more rented living units. Common areas include rental offices, elevators, entrances, hallways, laundry rooms, party rooms, exercise rooms, public restrooms, indoor swimming pool areas, and other places open to all tenants.
